1. Purpose of the Policy

Cleves School adheres to the DfE statutory guidance <u>statutory guidance on the cost of school uniforms</u>, and with our obligations under the <u>Human Rights Act 1998</u> and the <u>Equality Act 2010</u>. Additionally Cleves School follows the good practice set out in the DfE <u>non-statutory guidance</u> when determining school uniform expectations.

Cleves School recognises the value of having a uniform for the following reasons:

1.1 Safety

If all the pupils in a school wear a clearly recognisable uniform it is easy to identify strangers. On the way to and from the school it also affords a degree of safety as the pupils are part of a large body of young people who will look out for each other.

1.2 Preparation for the future

Many jobs require staff to wear a uniform and even if there isn't a uniform there is often a dress code. Uniform helps young people get used to dressing to a prescribed standard. It also helps them know and enjoy the difference between formal and informal dress.

1.3 Value for money and sustainability

Good quality uniform is in general a cost-effective way of dressing children and young people for school. It relieves individuals from the "pressure" to purchase and wear expensive, fashionable items. School uniform reduces "throw away fashion" purchases and recycling via in school second hand uniform pieces supports our sustainability ambitions and duty.

1.4 Ready to learn

Putting on the uniform is a signal you are preparing to learn.

1.5 A sense of pride and belonging

Cleves School wants to support the conditions where children and young people feel a sense of belonging and feel proud to be part of their school community.

2. The Aims and Objectives of the Uniform Policy

Cleves School has developed this policy to be clear about the school's expectations for uniform. This policy:

- Shows all stakeholders that Cleves School adheres to statutory duty and best practice in a transparent, consistent, considered and responsible way
- Gives clarity regarding the responsibilities of Trustees and the Headteacher.
- > Sets out the Cleves approach to requiring a uniform that is of reasonable cost and offers the best value for money for parents and carers.

3. The Benefits of an effective Uniform Policy

An effective Uniform Policy will add value to Cleves School, supporting the school's objectives by:

- Acting in accordance with the school's core value of inclusion
- Protecting the school's reputation
- Ensuring compliance with all legislation

4. Roles and responsibilities

4.1 The Trustees have a fundamental role to:

- Approve the Uniform Policy ensuring the policy is in line with Cleves School's core values
- Regularly review the Uniform Policy and approve changes or improvements to key elements of its processes and procedures, considering duties in respect of the Equalities Act 2010.
- Approve the uniform expectations and rules associated with appearance and in doing so consider:
 - How comfortable the uniform is for children and young people
 - How uniform in their school might affect groups represented in the school, especially those who share protected characteristics as defined by the Equality Act 2010
- ➤ Be sensitive to the needs of different cultures, races and religions and act reasonably in accommodating these needs, without compromising important school policies and routine, such as school safety or discipline. Legal judgments have not supported the absolute right of people of faith to wear garments or jewellery to indicate that faith
- Engage with parents and carers when developing or making any significant changes to the uniform policy and consider these views in determining the policy
- Consider the environmental impact in the manufacturing of the school uniform
- Approve suppliers of uniform and ensure that if the school has in place a contract with a specific supplier the supplier has an agreed procedure to deal with complaints about the supply and quality of uniforms

4.2 The Headteacher will:

- Operationally adhere to the Uniform Policy
- Monitor and review the implementation of the Uniform Policy
- Provide a mechanism for any changes to the Uniform Policy to be disseminated and discussed by trustees
- Engage with pupils when developing or making any significant changes to the uniform policy
- Ensure the Uniform expectations and rules associated with appearance are displayed on the school website and communicated to all stakeholders.
- Take a considered approach for uniform exceptions to be made in extreme weather including ventilation requirements in classrooms

Ensure information is provided to parents/carers where uniform can be sourced as well as ensuring second hand uniform sales are arranged and promoted.

4.3 Parents and cares will:

- Ensure their child has appropriate uniform and conforms to our no jewellery statement (including earrings).
- Agree that in accepting a place at Cleves School for their child they are agreeing to abide by Cleves' uniform expectations unless a reasonable adjustment has been agreed with the headteacher.

5. Communicating with parents/carers, children and young people regarding uniform

The school's uniform policy, expectations and rules associated with appearance must be:

- Displayed on the school's website, available for all parents, including parents of prospective pupils, and be easily understood.
- Explained to children, young people and staff

6. Cost of Uniform

- The school will ensure that uniform is affordable. Parents/carers should not have to think about the cost of a school uniform when choosing Cleves School.
- In considering cost, the Headteacher and trustees must consider the total cost of school uniform, considering all items of uniform or clothing that parents or carers will need to provide for their child while they are at the school. This includes PE kit.
- Cleves will make sure that arrangements are in place so that second-hand school uniforms are available for all parents. Information on second-hand uniforms will be clear for parents of current and prospective pupils and published on the school's website.

7. Compliance to wear the school uniform

- 7.1 Children and young people are expected to wear their school uniform correctly at all times (other than specified non-school uniform days) while:
 - On the school premises
 - > Travelling to and from school
 - At out-of-school events or on trips that are organised by the school, or where they are representing the school (if required)
- 7.2 Where there is non-compliance in wearing the uniform correctly then there will first be encouragement to do so and contact with parents/carers to understand if there are any barriers in doing so. Where possible the school will seek to work in partnership with parents/carers to resolve uniform issues.

- 7.3 Where the non-compliance of wearing uniform is a behavioural issue the matter will be dealt with in line with Cleves School's Behaviour Policy. In accordance with DfE guidance School uniform-GOV.UK (www.gov.uk) "The Headteacher can discipline your child for not wearing the school uniform. Your child can be suspended or expelled if they repeatedly ignore the uniform rules."
- 7.4 Headteachers have the authority to agree individual adaption to school uniform (which can be time limited or permanent) for reasons such as a child or young person with a special educational need with a significant sensory issue.

8. Equalities Act 2010 and public sector duty

- The Equality Act does not deal specifically with school uniform or other aspects of appearance such as hair colour and style, and the wearing of jewellery and make-up. It is for the trustees to decide on school uniform expectations and other rules relating to appearance. In doing this the trustees will have regard to their statutory obligations.
- Cleves School appreciates that there are evolving societal norms around dress. As with most schools currently the difference in uniform requirements for male and female children and young people is standard. This is not considered to be discriminatory unless one gender is particularly disadvantaged, both should have the same "overall" standard of dress.
- The Headteacher will consider whether flexibility is needed in relation to uniform to meet the needs of a child or young person, for example who is undergoing gender reassignment.
- Cleves School recognises that some children or young people may wish to wear distinctive garments for religious reasons. This could include wearing or carrying specific religious artefacts, not cutting their hair, dressing modestly, or covering their head. Children and young people have the right to manifest a religion or belief, but not necessarily at all times, places or in a particular manner. The Trustee Board will be sensitive to the needs of different cultures, races and religions and act reasonably in accommodating these needs, without compromising important school policies, such as school safety or discipline. It should be possible for most religious requirements to be met within the school uniform policy and trustees will act reasonably through consultation and dialogue.
- When regularly reviewing this policy Trustees and the Headteacher will consider changing societal views and will review parental/carer, children and young peoples' views.

9. Complaints and challenges to school uniform policy, expectations and rules associated with appearance

- Disputes about school uniforms will be resolved in accordance with Cleves School's Complaints Policy.
- Where the subject of a complaint is due to a child or young person's protected characteristic, trustees should carefully consider requests to vary their uniform policy.

10. Uniform Expectations

On Educational Visits, as well as during the school day, pupils will normally be expected to wear School Uniform. The items marked with an * can be ordered from Cleves School uniform supplier.

Jewellery

No jewellery should be worn at any time.

Earrings of any type must not be worn. This is for health and safety purposes and includes non-uniform days.

Watches may be worn although Cleves accepts no liability for any items that are lost or damaged.

Hair

All pupils must tie their hair back for school if it is long enough to do so.

Hair should be neat and tidy and tied away from the face.

Hair accessories; slides, scrunchies and bands are to be plain navy, black or white.

Extreme hairstyles and unnatural hair colours are not acceptable for the pupils to have in school.

The Halo Code

Cleves School champions the right of staff and students to embrace all Afro-hairstyles. We acknowledge that Afro-textured hair is an important part of our Black staff and students' racial, ethnic, cultural, and religious identities, and requires specific styling for hair health and maintenance.
